On the same day, the Company entered into the Xi'an Cares Subcontract Agreement with Xi'an Cares, pursuant to which the Company has agreed to subcontract to Xi'an Cares the overall construction of the departure system for the Yinchuan Airport Project, which includes but not limited to, the procurement, installation and testing of the required software and hardware and the system implementation as well as the two-year quality warranty for the departure system.

Qingdao Cares and Xi'an Cares are connected persons of the Company under the Listing Rules. Therefore, the entering of the Qingdao Cares Subcontract Agreement and the Xi'an Cares Subcontract Agreement and the transactions contemplated thereunder constitute connected transactions of the Company.

Qingdao Cares and Xi'an Cares are principally engaged in the provision of computer software and hardware development and data network services. Each of Qingdao Cares and Xi'an Cares has the necessary qualifications, capabilities and technological skills required to carry out the relevant works as specified under the Qingdao Cares Subcontract Agreement and the Xi'an Cares Subcontract Agreement, respectively. The Board is of the view that it will be for the benefit of the Company to subcontract to Qingdao Cares and Xi'an Cares the relevant work as specified under the aforementioned subcontract agreements.

The Directors (including the independent non-executive Directors) are of the view that the transactions under the Qingdao Cares Subcontract Agreement and the Xi'an Cares Subcontract Agreement will be conducted in the ordinary and usual course of business of the Group and on normal commercial terms, and that the terms of the transactions are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

## 4. IMPLICATIONS UNDER THE LISTING RULES

Qingdao Cares is a non-wholly-owned subsidiary of the Company, which is owned as to 51% by the Company, 36% by Qingdao International Airport Company\* (青島國 際機場集團有限公司) and 13% by Shanghai Civil Aviation East China Cares System Integration Co., Ltd.\* (上海民航華東凱亞系統集成有限公司). Shanghai Civil Aviation East China Cares System Integration Co., Ltd.\* is owned as to 41% by Eastern Airlines. Eastern Airlines is a subsidiary of Eastern Holding, and Eastern Holding is a substantial shareholder of the Company as at the date of this announcement. Qingdao Cares is therefore a connected person of the Company under the Listing Rules. As such, the transaction contemplated under the Qingdao Cares Subcontract Agreement constitutes a connected transaction of the Company.

Xi'an Cares is a non-wholly-owned subsidiary of the Company, which is owned as to 51% by the Company, 32% by Eastern Airlines, and 17% by China West Airport Group\* (西部機場集團). Eastern Airlines is a subsidiary of Eastern Holding and Eastern Holding is a substantial shareholder of the Company as at the date of this announcement. Xi'an Cares is therefore a connected person of the Company under the Listing Rules. As such, the transaction contemplated under the Xi'an Cares Subcontract Agreement constitutes a connected transaction of the Company.

Since the highest applicable Percentage Ratio calculated with reference to the each of the considerations under the Qingdao Cares Subcontract Agreement and the Xi'an Cares Subcontract Agreement is more than 0.1% but less than 5%, the transactions contemplated under the Qingdao Cares Subcontract Agreement and the Xi'an Cares Subcontract Agreement are subject to the reporting and announcement requirements but exempt from the independent Shareholders' approval requirement of Chapter 14A of the Listing Rules.

Mr. Li Yangmin has abstained from voting on the resolutions in relation to the Qingdao Cares Subcontract Agreement and the Xi'an Cares Subcontract Agreement as he is a director of Eastern Airlines. Save as disclosed above, none of the Directors has a material interest in the transactions contemplated under the Qingdao Cares Subcontract Agreement and the Xi'an Cares Subcontract Agreement, and none of them has abstained from voting on the relevant Board resolutions.
